Resolution Designating Edward Samuels as Redeveloper of Block 1411, Lot 25 of the City of Camden Tax Map (648 Berkley Street) Located in the Cooper Plaza Redevelopment Area and Authorizing a Redevelopment Agreement with the Redeveloper

Project Summary:

- 1. CRA owns land identified as Block 1411, Lot 25 on the City of Camden Tax Map, also known as 648 Berkley Street, Camden, NJ (the "Property"). The Property is a vacant, unimproved rectangular lot that is 980 SF (0.023 acre).
- 2. Edward Samuels, who owns and resides at 646 Berkley Street (Block 1411, Lot 24), which is located directly adjacent to the Property, proposes to acquire the Property and to make improvements to the Property including a cemented parking area, fencing, and decorative landscaping.
- 3. This Resolution seeks to designate Edward Samuels as the redeveloper of the Property and to authorize the sale of the Property to the Redeveloper.
- 4. The terms and conditions for the conveyance, include a sales price of \$10,300.00, which represents the fair market value established by an appraisal, plus the Agency's reasonable costs for legal, appraisal services, and redevelopment fees. In addition, the deed conveying the Property will state that if the Property is not improved within two (2) years, title shall revert to the CRA.

Resolution Designating Edward Samuels as Redeveloper of Block 1411, Lot 25 of the City of Camden Tax Map (648 Berkley Street) Located in the Cooper Plaza Redevelopment Area and Authorizing a Redevelopment Agreement with the Redeveloper

WHEREAS, the City of Camden Redevelopment Agency (CRA) is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, the City Council of the City of Camden ("City Council") adopted, in accordance with the Local Redevelopment and Housing Law, the Cooper Plaza Redevelopment Plan as to certain land within the City more particularly described therein (the "Redevelopment Area"); and

WHEREAS, City Council designated the CRA as the redevelopment entity pursuant to the Redevelopment Law to implement redevelopment plans and carry out redevelopment projects within the Redevelopment Area; and

WHEREAS, the Plan authorizes the CRA to designate and enter into agreements with redevelopers to undertake redevelopment projects that further the Plan; and

WHEREAS, CRA owns a vacant, unimproved parcel designated as Block 1411, Lot 25 on the Official Tax Map of the City of Camden, County of Camden, and State of New Jersey and also known as 648 Berkley Street, Camden, New Jersey (the "Property"); and

WHEREAS, Edward Samuels (the "Redeveloper"), who owns and resides at 646 Berkley Street (Block 1411, Lot 24) which is located directly adjacent to the Property, proposes to acquire the Property from CRA and to make improvements to the Property that include the installation of a parking area, fencing, and landscaping; and

WHEREAS, the Property will be sold to the Redeveloper for \$10,300.00, which represents the fair market value as determined by J. McHale & Associates, Inc. in a report dated December 2, 2016 which is acceptable to both the CRA and the Redeveloper, and for the reasonable costs incurred by the CRA for legal, appraisal, and redevelopment fees; and

WHEREAS, an accessory use for a single family residence is a permitted use under the Cooper Plaza Redevelopment Plan; and

WHEREAS, CRA deems the proposed use of the Property to be an appropriate use of the Property that is consistent with the Plan and that it is in the best interests of the CRA and the City to facilitate the proposed redevelopment of the Property.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency that Edward Samuels is hereby designated as the Redeveloper of Block 1411, Lot 25 on the Official Tax Map of the City of Camden, County of Camden, and State of New Jersey and, also known as 648 Berkley Street, Camden, New Jersey; and **BE IT FURTHER RESOLVED** that the Executive Director, a duly authorized representative of the Agency, is hereby authorized to enter into and perform the obligations under a redevelopment agreement including the sale of the Property to the Redeveloper for \$10,300.00, plus reasonable costs incurred by the CRA for legal and appraisal services and redevelopment fees and further that the deed conveying the Property shall provide that if the Property is not improved within two (2) years, title shall revert to the CRA.

BE IT FUTHER RESOLVED that the Executive Director, or her designee, is hereby authorized and directed to enter into a redevelopment agreement for the sale and to take all actions and execute all documents necessary to carry out the purposes of this resolution.
