Resolution Title:

Resolution Authorizing a Service Agreement with Federal Rent A Fence to Provide Construction Fencing at 100 Cooper Street for an Amount Not to Exceed \$1,200.00

- Currently the CRA maintains a construction fence around the CRA-owned property at 100 Cooper Street.
- The fence is rented from Federal Rent A Fence. The current agreement has expired and CRA must enter a new agreement with the vendor.

Resolution Authorizing a Service Agreement with Federal Rent A Fence to Provide Construction Fencing at 100 Cooper Street for an Amount Not to Exceed \$1,200.00

WHEREAS, the City of Camden Redevelopment Agency (CRA) is the owner of the building located at 100 Cooper Street known as Block 72 Lot 1 on the City of Camden Tax Map; and

WHEREAS, in the interest of public safety, the CRA has maintained a construction fence around the building; and

WHEREAS; the current service agreement with the vendor, Federal Rent A Fence has expired and it is in the best interest of the CRA and the public to enter into a new service agreement with the vendor; and

WHEREAS, the current vendor has proposed a cost of \$1,200.00 to continue to provide the construction fence for an additional period of one year; and

WHEREAS, the fence rental is an eligible cost under the US Environmental Protection Agency (EPA) Brownfields Cleanup Grant awarded for the building; and

NOW THEREFORE BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency that the Interim Executive Director of the Agency, its duly authorized representative, is hereby authorized and directed to enter into a Service Agreement with Federal Rent A Fence to provide construction fencing at 100 Cooper Street for an amount not to exceed \$1,200.00 for an additional one year period; and




