WHEREAS, the firm of Brown & Connery LLP, with its principal offices located at 6 North Broad Street, Woodbury, New Jersey 08096 has been deemed qualified to provide the required General Counsel Legal Services for the year 2022, and

WHEREAS, the CRA desires to execute a professional services contract pursuant to N.J.S.A. 40A 11-5 ((1) (a)(i)) with the firm of Brown & Connery, LLP to provide General Counsel Legal Services at the hourly rates submitted in their proposal with a contract expiration date of February 28, 2023.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency that the Interim Executive Director, a duly authorized representative of the Agency, is hereby authorized to enter into a one-year professional services contract with the firm of Brown & Connery, LLP to provide General Counsel Legal Services at a cost not to exceed \$100,000.00 at the hourly rates set forth in the proposal submitted by Brown & Connery, LLP.

BE IT FURTHER RESOLVED, that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions, and execute all documents necessary to carry out the purposes of this resolution.
