WHEREAS, the City of Camden Redevelopment Agency ("CRA") is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, the City of Camden and CRA collectively own-six (6) vacant lots in Tax Block 177, which is part of the Lanning Square Redevelopment Area; and

WHEREAS, the CRA proposes to purchase an additional lot and a vacant building within Block 177 from Ronald Yellin and Jonathan Yellin, the current owners of the properties in order to create an assemblage of properties that would be attractive for redevelopment; and

WHEREAS, the acquisition would be by voluntary sale by the property owners for the negotiated price of \$246,576.00; and

WHEREAS, the source of funds for the purchase would be from an Economic Recovery Board (ERB) Acquisition Grant, which is available for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency that the Interim Executive Director of the Agency, a duly authorized representative of the Agency, is hereby authorized to negotiate and enter into an Agreement of Sale for the purchase of 428 and 434 Martin Luther King Boulevard, Camden, New Jersey (Block 177, Lots 42 & 45 on the City of Camden Tax Map) for the negotiated purchase price of \$246,576.00 and to complete the acquisition of this property pursuant to the terms of such agreement of sale; and

BE IT FURTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized to take all actions and execute all documents necessary to carry out the purposes of this resolution.
