**WHEREAS**, the City of Camden Redevelopment Agency (“CRA”) desires to designate an Official Newspaper for the publication of Advertisements and Notices required by law to be published in the official newspaper of the CRA; and

**WHEREAS**, CRA also desires to designate two newspapers for the publication of advertisements and notices pursuant to New Jersey’s Open Public Meetings Act, N.J.S.A. 10:4-6 et. seq.; and

**WHEREAS**, the Courier-Post Newspaper does qualify as a Legal Newspaper and meets all requirements as to publication and circulation under New Jersey State law and is the Official Newspaper of the City of Camden for 2022.

**WHEREAS**, the Courier- Post Newspaper and the Philadelphia Inquirer Newspaper are the two newspapers that have the greatest likelihood of informing the public within the City of Camden.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the City of Camden Redevelopment Agency that the Courier-Post Newspaper is hereby designated as the Official Newspaper of the CRA for the publication of all Advertisements and Notices required by law to be published in the Official Newspaper of the CRA up and until the date of the Reorganization Meeting of the CRA in January, 2023; and

**BE IT FUTHER RESOLVED** that the Courier- Post Newspaper and the Philadelphia Inquirer Newspaper are designated by the CRA as the two newspapers for the publication of notices and advertisements pursuant to New Jersey’s Open Public Meetings Act, N.J.S.A. 10:4-6 et. seq. up and until the date of the Reorganization Meeting of the CRA in January, 2023, and

**BE IT FURTHER RESOLVED** that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute any and all other documents necessary to effectuate the purposes of this Resolution.
