- WHEREAS, the City of Camden Redevelopment Agency (CRA) is charged with the duty of redevelopment throughout the City of Camden; and
- WHEREAS, Councilwoman Marilyn Torres retired CRA effective July 13, 2022, following a dedicated period of service commencing in 2014; and

- WHEREAS, Councilwoman Torres has additionally demonstrated commitment to representing the interests and vision of the City of Camden as a Councilperson during the administrations of Presidents Francisco "Frank" Moran, Curtis Jenkins, and Angel Fuentes; and
- WHEREAS, prior to this appointment, Councilwoman Torres served as Chairperson of the Camden County Human Relations Commission and was a Commissioner for the Housing Authority of the City of Camden. She also is a former outreach worker for Operation Cease Fire—an initiative focused on reducing gun violence. Additionally, for more than three decades, she was the District Parent Coordinator for the Camden Board of Education.
- WHEREAS, Councilwoman Torres infused her responsibilities with diligence, faith, and passion, and
- WHEREAS, it is appropriate from time to time for CRA to honor those individuals who have served the City of Camden with dedication and distinction,
