Premium (Hazard) Pay Plan

The City of Camden Redevelopment Agency (CRA) desires to voluntarily compensate its employees with Premium Pay as a way to recognize its appreciation for the diligence and hard work exhibited during the very difficult period of the Pandemic.

CRA proposes to implement a Premium (Hazard) Pay Plan, based upon the terms and criteria set forth in the Premium Pay Plan adopted by the City of Camden for its employees in 2022. The total compensation for current eligible CRA employees is \$34,800.00. The terms and criteria upon which employees are eligible to be compensated under the Plan is set forth below:

Eligibility for Premium Pay

- Must have worked between March 16, 2020 and June 28, 2021
- Must be a current, active employee on the date the CRA Board of Commissioners approves the Resolution (not eligible if you have resigned, retired, or have been terminated).
- All time entries registered by official timesheets. Work from home hours are not eligible for hazard pay.
- Does not include overtime hours.
- A sliding scale is incorporated and as follows:

Scale for Premium (Hazard) Pay

1-299 hours	\$400.00
300-499 hours	\$1,500.00
500-749 hours	\$2,000.00
750-1250 hours	\$3,500.00
1250-1999 hours	\$4,000.00
2000 hours and above	\$4,500.00
