#### **Interim Executive Director's Report**

**Comments:** Ms. Simpson informed the board Resolution A is a request from Camden Renaissance to extend the deadlines for Phase 2 of the Admiral Wilson Boulevard Redevelopment Project. Resolution B is a request from Millennial Partners d/b/a 418 Federal Street the former Camden Library for an extension of time to complete construction of the improvements to the building from 36-months to 72-months.

Ms. Simpson also provided several project updates; 1800 Davis Street, Knox Gelatin II Site, Reliable Tire Site, and Yaffa Dirt Pile.

1800 Davis Street Site – CCIA has completed the demolition of the building and the title and financing closing for the project will take place end of October 2023. This extraordinary public/private/institutional collaboration plan is for the construction of a 4-story mixed-use 55,000-square foot building with 47 units for the 55 and older community on floors two through four, and commercial space on the first floor, which would include a Virtua Health, operated and managed primary health care facility.

<u>The Knox Gelatin II Site</u> – The City extended the term of the Shared Services Agreement with CRA, and CRA authorized a Sub-grant to increase funding for the cleanup of the 6-acre site slated for a residential end use. The Knox site is located to the south of the North Camden Waterfront Park aka Sadler's Poynt Park. Discussions with CCIA are positive, regarding the demolition and removal of several concrete foundations left on the site (estimated to cost \$1MM).

<u>Reliable Tire</u> – Parkside Business & Community in Progress (PBCIP) hosted a presentation by CRA and Michele Christina of BRS, Inc. on September 27, 2023 at PBCIP's Monthly Meeting to inform community

of the environmental remediation that will be underway at the site. Ms. Simpson thanked Commissioners Collins and Gainey-Humphrey for their attendance at this meeting.

<u>Yaffa Dirt Pile Site</u> - Ms. Simpson informed the Commissioners a community update for actions at the site, which attendees will include the Mayor, City B.A., and BRS. The Meeting will be hosted at New Fellowship UAME Church located in the Bergen Square neighborhood. Flyers were distributed by the City and information is posted the CRA's website and in the Mayor's Office. The timeline for the estimated 56 tons of contaminated soil removal is expected to last four months.

Mr. Sheehan spoke to several challenges, specifically setting forth the reasons for the extension. A substantial sum has been expended in interior demolition and stabilization of the building and after several potential deals; none have been successful. A private lender is willing to provide construction financing, however, the CRA's reverter rights in the redevelopment agreement is a risk the lender is not willing to take without an extension of the term.
