Resolution Amending Resolution 07-13-22D Authorizing a Shared Services Agreement with the City of Camden for Affirmative Action Officer Services and Compliance Officer Services

WHEREAS, the City of Camden Redevelopment Agency (“CRA”) is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, N.J.S.A. 40A:65-1 authorizes local units of government to enter into agreements for shared services; and

WHEREAS, CRA by Resolution 07-13-22D authorized the execution of a Shared Services Agreement with the City of Camden to provide certain Affirmative Action Officer Services and Compliance Officer Services under Chapter 348 of the City of Camden Code, and

WHEREAS, the City of Camden and the CRA deem it necessary and appropriate to amend the term of the Shared Services Agreement for Affirmative Action Officer Services and Compliance Officer Services for a period of one additional year.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency Resolution 07-13-22D is hereby amended to extend the term of the Shared Services Agreement authorized by said resolution by one additional year to a new end date of June 30, 2024; and

BE IT FURTHER RESOLVED that the Interim Executive Director of the Agency, a duly authorized representative, is hereby authorized and directed to negotiate and execute an amendment to a shared services agreement with the City of Camden for the Agency to provide affirmative action and compliance officer services as described in the City of Camden Code under Chapter 348 for an additional term of one year from July 1, 2023 to June 30, 2024 for an amount not to exceed \$50,000.00; and

BE IT FURTHER RESOLVED that the affirmative action officer services and the compliance officer services shall be provided by Dwaine Williams, an employee of the Agency, or such other employee of the Agency as designated by the Interim Executive Director, all as described in the City of Camden Code under Chapter 348; and

BE IT FURTHER RESOLVED, that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
