WHEREAS, the historical marker is erected at various sites for the purpose of sharing New Jersey history with the general public.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency that the Interim Executive Director, a duly authorized representative of the Agency, is hereby authorized to negotiate and enter into a license agreement with the New Jersey Historical Commission to install and maintain a New Jersey Black heritage Trail Historical Marker for Black Liberator Reverend Alexander Heritage Newton on Block 154, Lot 8 of the Tax Map of the City of Camden in the Lanning Square Redevelopment Area; and

BE IT FUTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
