Comments: Ms. Simpson provided a comprehensive overview of significant activities and projects for the 2023 term and redevelopment opportunities for 2024. She reported several 2023-project achievements include the closing of title for the Admiral Wilson Boulevard/Matrix Site Phase I for a warehouse facility (Admiral Wilson North Redevelopment Area); closing of title for 1800 Davis Street/Oliver's Station for an innovative mixed use residential and ground floor primary medical care facility (Whitman Park); and the stewardship of CRA and BRS' in the removal of contaminated soil at the Yaffa Dirt Pile Site (Bergen Square).

Ms. Simpson reported several redevelopment opportunities for the 2024 term that include securing state approval to expand the Cramer Hill Brownfields Development Area to capture Federal Street (Cramer Hill Redevelopment Area); site acquisition for the Coriell headquarters site and its area-wide impact (Gateway Redevelopment Area); closing of title for Matrix Site Phase II to complement Phase I (Admiral Wilson North Redevelopment Area); and public collaborations/partnerships around the development of Radio Lofts (Downtown Redevelopment Area). She also spoke of residential development opportunities that include the ABC Barrel Site (Cooper Street Historic District), Ablett Village Phase IV (Cramer Hill Redevelopment Area), Casa Del Rio (North Camden), Blue Onyx (Gateway Redevelopment Area), Lanning Square Courts (Lanning Square) and issuance of RFPs for development, including around Linden Street Site (North Camden).

Ms. Simpson mentioned the ongoing activity around the Brownfields Program, including the remediation of Elijah Perry Park Phase 1 and Camden Community Partnership proceeding with park construction (Centerville Redevelopment Area); meeting any challenges for the cap repair at the former Harrison Avenue Landfill site (Cramer Hill Redeveloper Area); and the start of remedial activities at Judge Johnson Park (Liberty Park), North Camden Waterfront Park and Knox Site (North Camden), and Reliable Tire Site (Gateway Redevelopment Area) in the coming months.
