**Elijah Perry Park** – the Park opening will be September 17, 2024, at 11 AM. Commissioner Collins will represent the CRA on the speaking Agenda, as Ms. Simpson will be out of town. She invited member of the board to join the event. Also, she noted over \$1.1 million was secured by CRA for remediation of the park from the EPA and DEP, and \$2.3 million from other partners, including the City of Camden, Housing Authority, HUD and Camden Community Partnership for restoration of this signature recreational area.

**Reliable Tire-** a Camden based business, requires a site for business expansion. A third of its current staff of 400 are Camden residents. In the expansion plan an additional 50 employs will be added over the course of 3-5 years. The Reliable Tire site is suitable, cleaned up to a non-restricted standard. We are reviewing. Estimated timeline after approvals construction by first quarter 2026.

**Federal Street Corridor -**CRA will be submitting a request to City Council to enter into a shared services agreement for environmental assessment and investigation, redevelopment planning, and property reuse.

**Judge Robert B. Johnson Park-** Back on track. Camden County working to complete design plan by end of 2024. CRA targets first quarter 2025 for remediation bids.

**Yaffa Site** – Exciting update. The LSRP has completed the draft preliminary assessment report. Site investigations for below surface conditions are quickly moving forward, including soil and underground water sampling/testing.

**Camden Lutheran Housing** – EPA press event held, announcing a Camden Lutheran Housing award of \$1 million for environmental clean-up of the Front and Elm Street site, and eventual reuse as a residential townhouse development site. CRA and BRS assisted in the support and application to EPA.

**Parkside Place PBCIP and Cinnaire -** will be before the NJ Mortgage Finance Agency board in September and NJEDA board in October for financing approvals. Closing on schedule by end of December. Construction to begin first quarter of 2025.

**Casa Del Rio Town House project -** awarded a total of \$12 million from DCA's Affordable Housing Trust Fund Program for phased development of 26 single-family town homes in North Camden. Construction targeted for the second quarter of 2025.

Oliver's Station - Construction started the first quarter of 2024, approaching 30 to 40% completion.
