Comments: Ms. Simpson provided several updates, including a current RFP for the Linden Street area of North Camden, a key westbound gateway corridor connecting Route 30 and I-676 to Downtown Camden. The site is bordered by Linden Street, 9th Street, 10th Street, Kimber Street, and Fern Street, and is surrounded by residential, commercial, and institutional uses.

She announced notice of an October 2025 groundbreaking hosted by the Coriell Institute for Medical Research for development of an \$80 million strategic innovation center that will include its headquarters, co-working space, and bio-research laboratory space for emerging biotech companies. The 45,000 square foot Center has significant financial support from the NJ Economic Development Authority and is the first such center in South Jersey. It is expected to create an estimated 100 construction related jobs, and 150 permanent jobs. Also, mentioned is the PBCIP Walnut and Princess residential project and two resolutions for site assembly expected for the board's consideration at the regular meeting. This preservation and stabilization project is in an area of Parkside that borders the planned Coriell Strategic Innovation Center.
