**Resolution Amending Resolution 06-11-25E that Authorized a Shared Services Agreement with the City of Camden for Affirmative Action and Compliance Officer Services to Reflect that the Services Will be Provided by an Amendment to the Existing Agreement and Not by a New Agreement**

**WHEREAS**, N.J.S.A. 40A:65-1 authorizes local units of government to enter into agreements for shared services; and

**WHEREAS**, CRA by Resolution 06-09-21D did authorize the execution of a Shared Services Agreement with the City of Camden for CRA to provide certain Affirmative Action Officer Services and Compliance Officer Services to the City under Chapter 348 of the City of Camden Code; and

**WHEREAS**, the term of the agreement has been extended by previous actions of the Board; and

**WHEREAS**, CRA by Resolution 06-11-25E authorized a new Shared Services Agreement with the City of Camden for CRA to provide Affirmative Action Officer Services and Compliance Officer services in the amount of \$50,000.00 for the term of one year; and

**WHEREAS**, this resolution is to correct the previous action taken to accurately reflect that the services will be provided by an amendment to the previous Shared Services Agreement and not under a new agreement; and

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the City of Camden Redevelopment Agency Resolution 06-11-25E is hereby amended to reflect that the that the Affirmative Action Officer Services and Compliance Officer Services will be provided by an amendment to the previous Shared Services Agreement with the City of Camden and not under a new agreement.; and

**BE IT FURTHER RESOLVED** that the Executive Director of the Agency, a duly authorized representative, is hereby authorized and directed to negotiate and execute an amendment to a shared services agreement with the City of Camden for the Agency to continue providing affirmative action and compliance officer services to the City as described in the City of Camden Code under Chapter 348 for an additional term of one year until September 30, 2026 for an amount not to exceed \$50,000.00; and

**BE IT FURTHER RESOLVED** that the affirmative action officer services and the compliance officer services shall be provided by Dwaine Williams, an employee of the Agency, or such other employee of the Agency as designated by the Executive Director, all as described in the City of Camden Code under Chapter 348; and

**BE IT FURTHER RESOLVED** that the Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
