**Resolution Title:**

**Resolution Authorizing a Pre-Qualified List of Appraisal Companies for a Period of One-Year**

**Project Summary:**

- This resolution establishes a list of “pre-qualified” appraisal companies from which the CRA will solicit cost proposals for various real estate transactions and related matters.
- Cost estimates and proposals will be obtained from pre-qualified firms prior to awarding a contract. CRA will review and approve the scope of services and cost estimate on a site-specific basis and the resulting professional service contracts will be the subject of further board action.

**Purpose of Resolution:**

To establish a pre-qualified list of appraisal firms

**Award Process:**

A Request for Qualifications (“RFQ”) for appraisal services was advertised in the Courier Post Newspaper and Philadelphia Inquirer and on the CRA Web Site in accordance with the ‘fair and open’ process and procedures for N.J.S.A. 19:44A-20.4 et. seq.

**Resolution Authorizing a Pre-Qualified List of Appraisal Companies for a Period of One-Year**

**WHEREAS**, the City of Camden Redevelopment Agency (CRA) is charged with the duty of redevelopment throughout the City of Camden; and

**WHEREAS**, CRA may require appraisal services in the furtherance of redevelopment transactions and projects; and

**WHEREAS**, it is in the best interest of the CRA to have a list of pre-qualified appraisal companies for a period of one-year for 2026 to 2027; and

**WHEREAS**, CRA, to procure these services, advertised in the Courier Post and Philadelphia Inquirer newspapers on February 20, 2026 and on its Web Site a Request for Qualifications for appraisal firms for 2026, pursuant to the 'fair and open' process and procedures for N.J.S.A. 19:44A-20.4 et. seq.; and

**WHEREAS**, CRA through its established evaluation process, determined that the firms listed in Attachment A of this Resolution are qualified to be included on the Pre-Qualified List; and

**WHEREAS**, CRA is not committed to contract any work to firms pre-qualified to conduct appraisal services, and

**WHEREAS**, CRA will solicit site-specific cost estimates and proposals from pre-qualified firms prior to awarding a contract, and will review and approve the scope of work and cost estimate, which will be subject to further CRA Board approval.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the Camden Redevelopment Agency hereby authorizes the Executive Director of the Agency, a duly authorized representative of the Agency, to establish a List of Pre-Qualified Appraisal Companies that appear on Exhibit A for a period of one-year; and

**BE IT FURTHER RESOLVED**, that the Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
