NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency that the Courier-Post Newspaper is hereby designated as the official Newspaper of the CRA for the publication of all Advertisements and Notices required by law to be published in the official newspaper of the CRA up and until the date of the Reorganization Meeting of the CRA in January, 2027; and

BE IT FURTHER RESOLVED, that the Executive Director, or her designee, is hereby authorized and directed to take all actions and execute any and all other documents necessary to effectuate the purposes of this resolution.
