Gregory Ricciardi of Parker McKay introduced George Sowa of Brandywine Trust Realty and he thanked the commissioners for the opportunity afforded with approval of the sub-redevelopment for Subaru. Mr. Sowa also reiterated a prior position regarding the goal of creating a community; not just with businesses, but with the residents of Camden as well. He also asked that bicycle stands be available at the developed sites. Olivia Glenn of the New Jersey Conservation Foundation thanked the commissioners for approving the plan and stated she is delighted to hear of the Subaru plan and is looking forward to working together on its execution.
