## **Project Summary:**

- TRC Environmental Corporation (TRC) is currently conducting a Supplemental Remedial Investigation of the balance of the Harrison Avenue Landfill.
- DEP has requested additional Tasks as part of the closure and redevelopment of the Landfill.
- TRC has proposed to complete the required work for the amount of \$206,356.00 which amount has been deemed acceptable by the granting sources.

### **Purpose of Resolution:**

The CRA engage TRC to conduct a remedial Investigation of the Balance of the Harrison Avenue Landfill. The DEP has requested additional tasks in connection with the Remedial Investigation

#### **Award Process:**

These services were not competitively procured because of the professional nature of the environmental information developed thus far in the project. It has been deemed most appropriate and practical not to engage a new environmental firm to perform these services.

Resolution Authorizing a Professional Services Agreement with TRC Environmental Corporation For a Supplemental Remedial Investigation and Additional Task For the Balance of the Harrison Avenue Landfill (Block 809 Lot 7 of the City of Camden Tax Map) for an amount not to exceed \$206,356.00.

WHEREAS, the City of Camden Redevelopment Agency ("CRA") is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, the CRA intends to redevelop the Balance of Harrison Avenue Landfill known as Block 809, Lot 7 of the City of Camden Tax Map (Site) for a solar power generating facility, Natural Resource Restoration and as public open space; and

WHEREAS, by Resolution 11-12-15E the CRA authorized a professional services agreement with TRC Environmental Corporation to conduct a Supplemental Remedial Investigation and Groundwater Investigation of the Site; and

WHEREAS, as a part of the Closure and redevelopment of the Landfill, the New Jersey Department of Environmental Protection (DEP) has required additional remedial investigation tasks; and

**WHEREAS**, by Resolution 01-13-16A the CRA accepted a grant from the New Jersey Hazardous Discharge Site Remediation Fund (HDSRF) to fund the Remedial Investigation; and

WHEREAS, additional funds are also available from USEPA Harrison Avenue Landfill Cleanup Grants; and

WHEREAS, TRC Engineering Corporation has agreed to complete the required additional work for a cost not to exceed \$206,356.00 which amount has been deemed by the granting sources to be an acceptable amount for the proposed work; and

WHEREAS, the full cost of the work authorized by this resolution will be covered by HDSRF and USEPA grants as itemized in the resolution summary; and

WHEREAS, because of the professional nature of the environmental information developed thus far in the project, it has been deemed most appropriate and practical not to engage a new environmental firm to perform these services

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the City of Camden Redevelopment Agency, that the Executive Director, a duly authorized representative of the Agency, is hereby authorized and directed to enter into a professional services agreement with TRC Environmental Corporation to conduct Remedial Investigation-Additional Tasks of the Harrison Avenue Landfill for an amount not to exceed \$206,356.00; and

**BE IT FURTHER RESOLVED** that the Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
