#### **Resolution Title:**

Resolution Rescinding Resolution 12-13-17B and Authorizing a Contract with Active Remediation Technologies, Inc. for Environmental Remediation and Waste Disposal Services at the Harrison Avenue Landfill (Block 809 Lots 7 & 13 the City of Camden Tax Map) for an Amount Not to Exceed \$75,682.10 Total Bid

# **Project Summary:**

- The New Jersey Department of Environmental Protection Office of Natural Resource Restoration (DEP) proposes to redevelop the remaining portion of the Harrison Avenue Landfill for shoreline protection, natural resource restoration, landfill closure and park construction.
- Construction is anticipated to begin in early 2018 and prior to that the CRA is obligated to conduct remediation of a contaminated "hot spot" and dispose of the waste.

To authorize a non-professional Contract

An Invitation for Bid was advertised in the newspaper. Five responses.

WHEREAS, the City of Camden Redevelopment Agency ("CRA") is charged with the duty of redevelopment throughout the city of Camden; and

WHEREAS, the New Jersey Department of Environmental Protection, Office of Natural Resource Restoration ("DEP") proposes to redevelop the Harrison Avenue Landfill, which is designated as Block 809 Lots 7 & 13 on the City of Camden Tax Map (the "Site") for shoreline protection, natural resource restoration, landfill closure, and park construction (the "Project"); and

WHEREAS, prior to the DEP commencing the Project, the CRA is obligated to conduct limited environmental remediation and waste disposal identified at the Site (the "Work"); and

WHEREAS, in order to procure the Work, the CRA advertised an Invitation for Bids, entitled, "Environmental Remediation & Waste Disposal Harrison Avenue Landfill E. State Street & Harrison Avenue Camden, New Jersey", dated January 12, 2018, in accordance with the "fair and open" process and procedures established under the regulations and amendments to N.J.S.A. 19:44A-20.4 et seq.; and

WHEREAS, through this process, the CRA determined that Active Environmental Technologies, Inc.is the lowest responsive bidder; and

WHEREAS, the cost of the Work is eligible under the CRA's Harrison Avenue Landfill Hazardous Discharge Site Remediation Grant(s); and

WHEREAS, a contract was approved for this work by Resolution 12-13-17B but the procurement is being repeated in order to advertise in the official newspaper of the Board.

**NOW THEREFORE BE IT RESOLVED**, by the governing body of the City of Camden Redevelopment Agency that Resolution 12-13-17B is hereby rescinded;

**BE IT FURTHER RESOLVED** that the Interim Executive Director of the Agency, a duly authorized representative, is hereby authorized and directed to enter into a Contract with Active Environmental Technologies, Inc. For Environmental Remediation and Waste Disposal Services at the Harrison Avenue Landfill for an amount not to exceed \$75,682.10 Total Bid; and

**BE IT FURTHER RESOLVED**, the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
