**WHEREAS**, Resolution 05-10-17E authorized the acceptance of property designated as Block 170, Lot 61 on the City of Camden Tax Map (the "HACC Property") from the Housing Authority of the City of Camden (HACC) for purposes of assembling property adjacent to and in connection with the redevelopment of the Former Public Library on Federal Street; and

WHEREAS, HACC has requested that the City of Camden Redevelopment Agency (CRA) convey to HACC CRA property located in the Centerville Neighborhood and designated as Block 567, Lots 16 & 20 on the City of Camden Tax Map (the "CRA Property") in exchange for the HACC Property; and

**WHEREAS**, the CRA Property is not currently committed to any redevelopment project; and

**NOW THEREFORE BE IT RESOLVED**, by the governing body of the City of Camden Redevelopment Agency, that Resolution 05-10-17E is hereby amended to authorize the conveyance by the CRA of the property designated as Block 567, Lots 16 & 20 on the City of Camden Tax Map to the Housing Authority of the City of Camden in exchange for the property designated as Block 170, Lot 61 on the City of Camden Tax Map from the HACC and the acceptance of such property by the CRA; and

**BE IT FURTHER RESOLVED**, that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution; and

**BE IT FURTHER RESOLVED**, that all of the actions set forth in this resolution, including the proposed re-conveyance, shall be void, if the HACC determines that it will not convey the HACC Property to the CRA.
