WHEREAS, the City of Camden (City) conveyed by a deed, dated April 13, 2017, to the City of Camden Redevelopment Agency (CRA) a Property designated as Block 170, Lot 40 on the City Tax Map, which conveyance was authorized by CRA Resolution 02-08-17J; and

WHEREAS, the Property is the location of the former Camden Public Library, which the CRA proposes to re-convey to a redeveloper for purposes of redevelopment; and

WHEREAS, during the course of title searches, it was determined that the Property, as conveyed, also included a portion of the vacated former Taylor Street and a portion of the vacated former Fourth Street within Block 170, which are further depicted as the striped area on the City of Camden Tax Map attached as Exhibit A hereto ("the Vacated Streets"); and

WHEREAS, the Vacated Streets are actively used by Camden County for pedestrian access to the Hall of Justice and it is in the best interest of the CRA, Camden County, and the general public to preserve the public access;

NOW THEREFORE BE IT RESOLVED, by the governing body of the City of Camden Redevelopment Agency, that the Agency is hereby authorized and directed to convey a portion of Block 170 Lot 40, as herein depicted on Exhibit A, and proposed to be designated as Block 170 Block 40.01, to Camden County; and

BE IT FURTHER RESOLVED, that the conveyance from the CRA to the Camden County shall be for no cost; and

BE IT FURTHER RESOLVED that the Interim Executive Director, or her designee, is hereby authorized and directed to takes all actions, and execute all documents necessary to carry out the purposes of this resolution.




