WHEREAS, pursuant to N.J.S.A. 40A 11-5 ((1) (a)(i)) the CRA desires to execute a professional services contract with the firm of Brown & Connery, LLP to provide General Counsel Legal Services at the hourly rates submitted in their proposal with a contract expiration date of February 28, 2020; and

NOW, THEREFORE, BE IT RESOLVED by the governing body of the City of Camden Redevelopment Agency, that the Interim Executive Director, a duly authorized representative of the Agency, is hereby authorized to enter into a one year professional services contract with the firm of Brown & Connery, LLP to provide General Counsel Legal Services at a cost not to exceed One Hundred Thousand Dollars (\$100,000) at the hourly rates set forth in the proposal submitted by Brown & Connery, LLP..
