#### **Resolution Title:**

Resolution Amending Resolution 06-12-19C to Correct a Statement About the Procurement Process Regarding a Professional Services Agreement with Steven W. Bartelt MAI, SRA, AI-GRS for Appraisal Services for Property Designated as Block 72 Lot 28 on the Camden City Tax Map in the Camden Downtown Redevelopment Area in an Amount not to Exceed \$2,850.00

### **Project Summary:**

- By Resolution 06-12-19C the CRA authorized a professional services agreement with Steven W. Bartelt for appraisal services for Block 72, Lot 28 on the City of Camden Tax Map. This resolution incorrectly stated that, "the CRA solicited price quotes from appraisers on the CRA's approved list of appraisers." Although price proposals were solicited from appraisers, at the time of the solicitation the CRA did not have in place an approved list of appraisers
- This resolution seeks to amend Resolution 06-12-19C to correct the above statement but wishes to proceed with the approved professional services agreement previously approved by Resolution 06-12-19C.

Resolution Amending Resolution 06-12-19C to Correct a Statement About the Procurement Process Regarding a Professional Services Agreement with Steven W. WHEAREAS, the City of Camden Redevelopment Agency ("CRA") is charged with the duty of redevelopment throughout the City of Camden; and

WHEREAS, the CRA is the title owner of certain property designated as Block 72 Lot 28 on the City of Camden Tax Map, in the Camden Downtown Redevelopment Area (the "CRA Property"); and

WHEREAS, as appraisal report will provide the current fair market value of the leasehold of the CRA Property to be used in the negotiation of the rent for an anticipated lease agreement; and

WHEREAS, by Resolution 06-12-19C the CRA authorized a professional services agreement with Steven W. Bartelt for appraisal services for the CRA Property, however this resolution incorrectly stated that, "the CRA solicited price quotes from appraisers on the CRA's approved list of appraisers."

WHEREAS, although price proposals were solicited from appraisers for the award made in Resolution 06-12-19C, at the time of the solicitation the CRA did not have in place an approved list of appraisers; and

WHEREAS, this resolution seeks to amend Resolution 06-12-19C to correct the above statement but wishes to proceed with the professional services agreement previously approved by Resolution 06-12-19C.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the City of Camden Redevelopment Agency, that Resolution O6-12-19C is hereby amended to indicate that while price proposals were solicited from appraisers for the award made in Resolution 06-12-19C, the CRA did not have in place an approved list of appraisers at the time; and; and

**BE IT FURTHER RESOLVED** that the above correction does not affect the decision to proceed with the professional services agreement authorized in Resolution 06-12-19C and the CRA wishes to proceed with that professional service agreement; and

**BE IT IS FURTHER RESOLVED** that except as modified by this resolution, Resolution 06-12-19C shall remain in full force and effect; and

**BE IT FURTHER RESOLVED** that the Interim Executive Director, or her designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purposes of this resolution.
